## 【Admission and Tuition Fee Exemption for Nagoya University Independently Program】

Please confirm carefully Notes below

ELIGIBILITY	<p><b>Those who have repeated a year or have exceeded the standard period of study are not eligible for Tuition Fee Exemption in principle</b>, but those who have repeated a year or have exceeded the standard period of study for less than one year may be accepted for some reason.</p> <p>"Repeating year" means staying in the same grade, and "exceeding the standard period of study" means that the period of enrollment including the period of leave of absence exceeds the regular period of study.</p> <p>If you take a leave of absence or withdraw from the University before the application results are known, you will withdraw your application and must pay the tuition fee.</p> <p>For those who are on-campus academic advancement should apply according to the schedule for students admitted in FY2026. Please apply with the new student number after April. If you apply with the student number of the previous course, the application will be invalid.</p>
SUBMISSION OF APPLICATION DOCUMENTS	<p>When sending by postal mail, please send by Acceptance-recorded mail or Letter Pack Light, etc., which will keep a record. In the column of delivery phone number, Please fill in Student Support Division's phone, (052-789-2172). Inquiries regarding the arrival of documents will not be answered. However any other questions will be accepted by e-mail.</p> <p>(Reference) The least expensive mailing method with a record is "Acceptance-recorded mail". (within 25g ¥320/within 50g ¥320~350)</p> <p>Please write "Admission Fee Exemption application form enclosed" in red on the front of the envelop.</p> <p>Make a copy of all the documents to be submitted and keep the copy in a safe place until the result is announced.</p> <p>If there are any corrections, we may ask you to make corrections to the copy and resubmit it.</p> <p>Application must be made by the applicant themselves. Applications will not be accepted from any other than the applicant, such as friends, household supporters, etc.</p>
CONTACT AFTER SUBMISSION OF APPLICATION DOCUMENTS	<p><b>When we contact you, we will send email to THERS email address.</b></p> <p>During the review process, there may be instances in which documents are found to be insufficient, require further clarification, etc. and, as a result, you may be asked to submit additional documents or provide confirmation/certifications even after the period for submitting application documents has passed. So please reply promptly to any communication from the university staff.</p> <p>We will not be held responsible for any disadvantage's applicants suffer due to failing to appropriately communicate with our staff.</p> <p>We will also not accept applications after the application period has passed. Please note that if you do not submit missing or additionally requested documents by the designated date, your application will be considered incomplete and therefore excluded.</p>

<p><b>PAYMENT OF THE ADMISSION/ TUITION FEES BEFORE RESULT NOTIFICATION</b></p>	<p>Those applying for the Admission Fee Exemption/Deferred Payment and Tuition Fee Exemption will be exempt from paying the fee until after the application results are announced.</p> <p>Note that admission and tuition fees once paid is non-refundable. (Excluding admission fee for G30 program students.) So please be careful not to pay admission and tuition fee until after the application results are announced.</p>
<p><b>PAYMENT OF THE ADMISSION FEE</b></p>	<p>All Applicants of the Admission Fee Exemption are deferred to pay the Admission Fee until you are notified of the result. For those who are not exempted from the full amount of the Admission Fee, <b>please pay the Admission Fee by bank transfer to the designated bank account.</b>(within 20 days from the date of notification)</p> <p><b>【Result Notification of Admission Fee Exemption】</b> Admitted in April : Middle of July Admitted in October : Early December</p>
<p><b>DEFERRED PAYMENT OF THE ADMISSION FEE</b></p>	<p>Result of Deferred Payment will be noticed you with the Admission Fee Exemption. <b>【Deadline For Payment】</b> ●Deffered Payment Admitted in April : by the end of September Admitted in October : by the end of February</p> <p>●Not Approved For Deffered Payment/Unapplied For Deferred Payment →within 20 days from the date of notification</p>
<p><b>PAYMENT OF THE TUITION FEE</b></p>	<p>All Applicants of the Tuition Fee Exemption are deferred to pay the Tuition Fee until you are notified of the result.</p> <p>For those who are not exempted in full, the Tuition Fee will be deducted from your registered tuition transfer account on the date to be announced in the result notification. (Spring Semester: Late August, Fall Semester: Late December) <b>* Not a normal bank transfer date (Spring Semester : Late May, Fall Semester : Late November).</b> Please prepare an amount equivalent to the amount of tuition payment as the deposit balance in your bank account by the previous day.</p> <p><b>【Result Notification of Tuition Fee Exemption】</b> Spring semester : Early August Fall semester : Middle of December</p>
<p><b>REVOCATION OF EXEMPTION APPROVAL</b></p>	<p>In the case of being taken Disciplinary action or forgery or any false statements are found in the submitted documents, even after the Admission/Tuition Fees Exemption is aproved, then this approval will be revoked, and the applicant will be required to pay them.</p>
