- The Exemption Application after the period is not accepted.
- For those who are on-campus academic advancement should apply according to the schedule for students admitted in April 2026.
- The procedures is not completed if you only enter the application through the Tuition Fee Exemption Student Application System. The required documents must be submitted to the Student Support Division by the deadline.
- The Tuition Fee Exemption Student Application System only guarantees operation on-campus environment. Please contact the Student Support Division if you cannot use the on-campus system during the application period due to unavoidable circumstances. Graduate students can also use the service from off-campus by using VPN service. For details, please check VPN Service (<https://vpn-portal.nagoya-u.ac.jp/>).
- For information on how to enter the Tuition Fee Exemption Student Application System, please refer to "II. Tuition Fee Exemption Student Application System" in the Guideline.
- When sending by post mail, please send by Acceptance-recorded mail or Letter Pack light, etc. inquires regarding the arrival of documents will not be answered.
- If you apply for the "Both Spring and Fall Semester Application" this time, you do not need to apply again in the Fall Semester unless there are any changes to the application content. If there are changes to the application, you must submit a "Fall Semester change Application" during the application period for the second half. Please note that the exemption results will be reviewed and notified separately for both the Spring and Fall, so please check them.
